- a) the maximum height of buildings be reduced to 42m for the northern tower and 30m for the southern tower;
  - b) apply 'Clause 6.12 Affordable Housing' of the *Canada Bay Local Environmental Plan 2013* to the Site with a requirement for 8% Affordable Housing and identify the land on the Canada Bay Affordable Housing Map; and
  - c) apply 'Clause 6.14 Design Excellence' of the *Canada Bay Local Environmental Plan 2013* to the Site by identifying the land on the Canada Bay Design Excellence Map.
2. The following information be provided prior to the Planning Proposal being submitted to DPHI for Gateway Determination:
    - a) a review and update to the shadow diagrams having regard to:
      - i. the levels of the site and adjoining properties.
      - ii. the height of the southern building which must clearly show and consider the shadow impacts on the northern face of Liberty Grove development to the south (particularly 3 Bradley Place).
    - b) further analysis of the visual impacts of the proposed above ground car park upon the surrounding public and private properties;
    - c) provide a Biodiversity Assessment Report;
    - d) updated Acoustic Report to respond to Peer Review recommendations, including updated acoustic testing;
    - e) update Planning Proposal to identify an 8% affordable housing contribution.
  3. Council prepare draft development controls for the site for inclusion in the *Canada Bay Development Control Plan*.
  4. The *Canada Bay Affordable Housing Contribution Scheme* be amended to reflect the requirement for an 8% affordable housing contribution rate, with delegation granted to the General Manager to vary the final affordable housing contribution rate as a result of public benefits secured through a planning agreement.
  5. Delegation be granted to the General Manager to negotiate a draft Planning Agreement to address site access and public domain improvements.
  6. Authority be delegated to the General Manager to make minor variations to the Planning Proposal to correct any drafting errors or to ensure that it is consistent with the Gateway Determination.
  7. The Planning Proposal, draft Development Control Plan, draft Affordable Housing Contribution Scheme and draft Planning Agreement be endorsed for public exhibition in accordance with relevant conditions imposed under the Gateway Determination.
  8. In the event that any of the information provided in response to the Items in point 2 above being unsatisfactory, a further report be prepared and submitted to Council.
